Deed Restrictions: How can I get a copy?

We are always talking about Deed Restrictions. Each section has a slightly different version of the basic Deed Restrictions. It is important that we read and become familiar with the restrictions that govern our specific section.

You can find a copy of the Deed Restrictions for your section on our website located at www.foxwoodhoa.net. Click on the tab labeled "Documents and Forms" and click on your section. You can find your section by consulting your tax statement which will have your property description which includes you section, block, and lot numbers.

You may also have a copy of your Deed Restrictions with the closing package you received when you purchased your home. Call CMS or the Foxwood Phone Line if you have questions about your Deed Restrictions.
