SECURITY REPORT:

Sgt. OLD BUSINESS:

No ACC Applications were submitted in July.

NEW BUSINESS:

Ms. Gibbs updated the Board on the Foxwood Pool Shutdown by the Harris County Health Department on July 12, 2019. While it was only closed for two days, the reason was due to low levels of chlorine and PH factors. This was caused by a faulty breaker that tripped the pool pump. An emergency repair was completed

by Cravens Electric. The old breaker was replaced with a higher voltage amp, and a new telephone line was installed outside for pool access. The cost of the repairs totaled \$1,191.00. The fine paid to reinspect and open the pool cost \$600.00.

Ms. Gibbs then addressed the Board regarding Foxwood Meadows. This adjacent subdivision of 46 homes has shown interest in annexing into Foxwood HOA. She would like to speak with Mr. Gainer, the legal counsel, regarding this matter. The Board will consider the review in the future.
